___ **Wolf Lodge** (Available year-round) A rustic heated cabin, lower floor includes lounge with fireplace, kitchen with stove, refrigerator, and microwave, 2 bathroom stalls and 2 showers, 2nd floor provides dormitory sleeping for 20 plus. ----- \$200/ day

___ **Recreation Hall** (Available May 1st – Oct 31st) A large open room with view of camp, fireplace and stage, a kitchenette with refrigerator, sink, and microwave, and a single bathroom) ----- \$100/day

___ **Dining Hall with full kitchen** (Available May 1st – Oct 31st) Features a unique round dining room with fireplace in the center, seating for approx 125 people at picnic tables, a full commercial-style kitchen with stove w/griddle, convection oven, refrigerator, freezer, and microwave, and a single bathroom.) ----- \$300/day

___ **Cabins** (Available May 1st – October 31st) 13 A-Frame cabins (each sleeps up to 8), arranged into 3 secluded villages- Two groups w/4 cabins, One group w/ 5 cabins. Cabins are nearby outdoor bathhouse w/ flush toilets and sinks----- \$50 ea/day X ___ (quantity) = ___ total

___ **Pool and Bathhouse** (Available June 1st – September 1st; A certified lifeguard is required during use of pool. Group may bring their own by attaching Lifeguard certificate to application, OR the YWCA will provide a lifeguard at \$15/hr----- \$300/day

___ **Certified Lifeguard** ----- \$15/hour X ___ (number of hours) = ___ total

___ **Entire Camp facilities** ----- \$650/day

Deposit is required for each facility at \$100 each facility. If renting entire camp deposit amount is \$325. Upon vacating premises Caretaker will inspect rented facilities; if area is found reasonably clean and without any damages, deposit will be refunded.

There are 3 parking areas for your convenience- at the Lodge (limit 6 cars), by the Rec Hall, and lower lot near the bridge. NO parking is permitted along Sheepbridge Rd. Please discuss any parking concerns with caretaker prior to rental dates.

Sports and other recreational areas are available at no additional fees (Including: Fishing, Boating, Hiking, Basketball, Volleyball, and Gaga Ball.) Groups must provide their own equipment.

Guests must bring their own bedding, towels, paper products and trash bags. Please bring a cell phone with you in case of emergency as there are no public phones available with rentals.

Renters are responsible for taking trash and recyclables to appropriate dumpsters in lower parking lot. PLEASE do not leave any trash, recyclables, or cigarette butts on the ground. Doing so will hinder return of deposit.

Be sure to take all foods and belongings with you and leave furniture in buildings as found.

ALCOHOLIC BEVERAGES ARE NOT PERMITTED ON THE PREMISES unless prior approval is given by the YWCA for a specific event. An additional waiver is required and fees may apply. Contact Camp Caretaker upon applying.

In order to finalize the rental agreement, the YWCA must receive a copy of your insurance clearly stating the YWCA will not be held liable for any injuries while on the property. If not available, you may complete and submit the Hold Harmless in its place.
